CALL TO ORDER AND ROLL CALL

This Joint Board and TAC Work Session is to provide an opportunity to share how the regional Transportation Improvement Program, known as the TIP, is developed; how TIP projects are selected; considerations for TIP project selection; and the draft Call for TIP project request form.

The consulting firm of Kimely-Horn was selected to assist the SVMPO in preparing Work Session materials and will be facilitating this discussion.

The next TIP will cover the timeframe of FY25-FY29. It will be finalized and presented for recommendations and actions in the June TAC and Board meetings. No Call for TIP Projects is anticipated this year given the lack of available STBG funding for programming in FY25 & FY26. A Call for TIP projects is anticipated to be released in early 2025 for potential programming of FY27-FY30 STBG funding.

This intention of this Work Session is to develop strategies to successfully identify, fund, and implement a regional Transportation Improvement Program.

The Transportation Improvement Program identifies awarded projects for the next four-to five years using the STBG fund source, other federal funding, or grants that require placement in the regional TIP.
